de Souza Expert Facilitator Chemotherapy and Biotherapy Course – Parts 1 and 2

A. COURSE DESCRIPTION

This two-part course is part of the de Souza Expert Facilitator designation program. This course is designed to help RNs interested in facilitating de Souza Institute's Provincial Standardized Chemotherapy and Biotherapy (PSCB) course workshop in their local organization, who meet the eligibility criteria, become expert facilitators. The program will help participants apply theoretical frameworks and adult learning principles to the PSCB course, and gain insights into the process and standards for facilitating the course.

Part 1 (CBFT) of the course is the initial training program in which facilitators develop the skills required to facilitate de Souza Institute's standardized curriculum. The course is completed online and via webcast (zoom) conferencing.

In Part 2 (CBLL), participants attend and facilitate the PSCB workshop <u>twice</u>, within 18 months of completing CBFT. Your first workshop as a facilitator must be done with another de Souza expert facilitator, before you can independently facilitate the second workshop. Though you may also opt to co-facilitate <u>both</u> workshops with another de Souza expert facilitator. Once the requirements for both CBFT and CBLL have been completed, you will receive 1.0 de Souza credit towards the de Souza designation program.

B. COURSE OBJECTIVES

By the end of this course, you will be able to:

- Summarize theoretical frameworks, adult teaching learning principles, and standards guiding de Souza Institute's PSCB course
- Summarize your role as a course facilitator in light of adult teaching-learning principles and facilitation theory. Summarize how you can enhance your facilitation skills
- Articulate key elements of the chemotherapy and biotherapy standardized curriculum required for learners to be successful
- Explain how the curriculum can be adjusted to meet local needs for the course workshop (a core set of elements must be included for the curriculum to be certified as a de Souza standardized program)
- Explain the steps and process required to successfully facilitate the PSCB workshop
- Identify solutions to common challenging questions encountered during workshop facilitation with PSCB participants, and articulate responses relevant to participants' unique practice settings
- Summarize the process of maintaining your competency as a de Souza expert facilitator

C. MODES OF LEARNING

The main mechanisms to facilitate learning in this course will entail eLearning and a workshop. The eLearning environment fosters a self-directed approach so you can progress through the modules and exercises at a convenient time, at home or work. The course timetable, in Section **H** of the course syllabus, outlines our expectations for participants.

- eLearning: Sections and modules were developed by the de Souza education team to reflect the latest information on facilitation, and the most current set-up of the PSCB course process. The content is up-to-date and interactive.
- Readings: These readings are required to enhance the content related to adult teachinglearning principles, and facilitation skills.
- Workshops: Workshops (In-person or Virtual)

- In-person Workshop: If an in-person workshop is being offered at your organization or hospital, you must register to attend that in-person workshop. Active participation is required. A workshop evaluation must also be completed. You must download and complete the Jean Louis case study and bring it with you to the workshop. In-person workshops are only offered in January, April and September of each year. Additional dates may be added, but are dependent on local organization availability.
- <u>Virtual Workshop:</u> This option was added during the COVID-19 pandemic to accommodate policies and restrictions related to public health. For those not able to attend an in-person workshop because it is not offered at their organization or hospital or due to public health policies and restrictions, you must register to attend the virtual workshop on one of the specified dates. Active participation is required. Virtual workshops are offered in each cohort. The virtual workshop covers the core content presented at the in-person workshop, but does not include the hands-on components. You must download and complete the Jean Louis case study and bring it with you to the workshop.
- <u>Facilitator Agreement</u>: Review and sign the de Souza Institute policy guiding your role as a facilitator of the standardized course. This is required to receive access to the Facilitator Forum.
- <u>PSCB Workshop:</u> To ensure that you understand the workshop process and your role as a de Souza expert facilitator, you need to attend and facilitate <u>two</u> PSCB workshops (CBLL Part 2) within 18 months of completing CBFT Part 1. You are only required to co-facilitate <u>one</u> workshop with another de Souza facilitator, however you can opt to do this for both.

D. MODES OF EVALUATION

As part of the evaluation process, you are required to complete the following:

<u>Post Evaluation Survey</u>: At the end of the course, you will be required to complete a
post course evaluation survey, which can be accessed at the end of the eLearning
course.

When you have met all the requirements for the CBFT course, you will receive a downloadable certificate of completion via your "My Account".

de Souza Expert Facilitator Chemotherapy and Biotherapy Course – Parts 1 and 2

de Souza Institute must be notified when you have completed your facilitation requirement of two workshops, in order to receive your certificate of completion for CBLL and 1.0 credit towards de Souza designation in the domain of Developing Professional Practice and Leadership.

Please note: The certificates of completion via your "My Account" will be available within two weeks after the closing of the online course (CBFT) and after de Souza Institute has received notification/verified that you have completed the facilitation of two workshops.

E. CHEMOTHERAPY AND BIOTHERAPY FACILITATOR FORUM

The Chemotherapy and Biotherapy Facilitator Forum (CBFF) is a community of practice forum for all de Souza Institute expert facilitators. It is set up as a course in eLearning and includes all of the information, tools, and handouts required to facilitate the PSCB workshop. You will also find discussion forums where you can share additional resources with your co-facilitators across Ontario and Canada, enabling each of us to enhance and build program quality.

de Souza Institute also utilizes the forum to post key announcements, reminders and any updated information that may affect your facilitation of the PSCB workshop. You will be provided access to CBFF upon successful completion of CBFT.

G. EXPECTATIONS FOR PARTICIPANTS

To be successful in completing Part 1 (CBFT) of this course, you are encouraged to set aside 1 to 2 hours each week to complete each section as learning is primarily self-directed. The total learning hours for this course is 6.5 hours.

To be successful in completing Part 2 (CBLL) of this course, you will need to attend and facilitate the PSCB workshop <u>twice</u>, within 18 months of completing CBFT. Your first workshop as a facilitator must be done with another de Souza expert facilitator, before you can independently facilitate the second workshop. Though you may also opt to co-facilitate <u>both</u> workshops with another de Souza expert facilitator. The total number of hours for both workshops is 15 hours, and must involve a minimum of 3-4 colleagues per session. You will need to review facilitator material prior to facilitation to ensure meeting de Souza Institute standards. The total learning hours for part two of the program is 24 hours.

<u>Maintaining Competency as a Facilitator:</u> Facilitators are responsible to maintain their competency *independently*, after completing Parts 1 and 2 of the course by:

- Facilitating the PSCB workshop twice, every 18 months
- Completing the Chemotherapy Competency Maintenance Course (CCMD), every 12 to 24 months
- Participating in the annual facilitator maintenance meeting An informal, half to full day, symposium held every 14 to 24 months (via webcasting/zoom)
- Completing yearly tracking/confirming completion of mandatory activities
